### Authorized Agent(s) Setup

Authorized Agents will have access to the Send Rx screen in order to complete prescriptions on behalf of the authorizing provider. Authorizing Agents are provider specific and set up within the provider's demographics.



Pharmacy Administration screen now has added features:

- Icons before Pharmacy Name indicates type of pharmacy (hover over the icon to see pharmacy type:
  - 24 Hour Store
     ➡ Retail
     ★ Specialty
     Mail Order
- The Pill Icon (to far right of pharmacy information indicates types of messages the pharmacy accepts:




• The Edit Icon 🕝 to the far right allows for a Nickname of the Pharmacy for better identification:

Pharmacy Administration has two tabs:

- Clinic: Pharmacies added to the Clinic's pharmacy list.
  - Pharmacies can be manually added by clicking the Add Pharmacy icon (bottom right). Note that manually added pharmacies will not allow electronic prescribing.
- Surescripts Directory: Ability to search and select pharmacy to be added to the Clinic list.
- Pharmacies can also be added during the prescribing workflow (see below > Prescribing. Workflow) or within Patient Demographics (Patient > Preferred Pharmacy > click on + sign) > search/select pharmacy > bottom select to Add to Patient List or Add to Clinic List.

Prescriber: SPI Registration has been moved from eRx Admin to Chart > Administration > Prescriber Administration. The new screen now gives clinics the ability to register providers for electronic prescribing through Surescripts and to register for EPCS. The tab also shows the number of Available Licenses and current status of providers.

### **Prescribing Workflow**

Medications can be prescribed or refilled from the Health Summary or in the Medication section of a note.

**Health Summary** 

- Click on RX to prescribe a new medication/DME.
- Click on the Container to refill a medication.



**Chart Note – Medication Section:** 

- Click on the + icon to prescribe a New Medication select "New Rx".
- Click on the + icon to refill a medication select Medications Details and then select Refill.

Prescribe Medication window:

- Formulary information can be seen on the left panel if the required information is completed for the script: prescriber, pharmacy, and quantity.
- Pharmacy will be pulled from the patient demographics and a new pharmacy can be added to the patient and/or clinic pharmacy list from the Pharmacy field.
- Prescribing (PDR Brief) information can be found bottom right.
- Review and edit as needed.
- Click on Send Rx Now button (bottom right) to complete and send script.
  - Or Save to process later.
